

**Instructions for Completing the
AS-EPA Notice of Intent (NOI) to Import Hydrochlorofluorocarbons
(HCFCs)/Hydrofluorocarbons (HFCs) Form
For Importers in American Samoa Only**

NOI to Import HCFCs/HFCs Form

A copy of the NOI to Import HCFCs/HFCs Form can be found on the AS-EPA Website, as well as the complete instructions for the form.

Quick Instructions: Refer to the table below for more information when filling out the NOI form.

PART I: TO BE COMPLETED BY THE BUSINESS OWNER *BEFORE PURCHASE OF PRODUCT*

| Question | Description of Response |
|----------------------------|---|
| 1. Business Owner or Agent | If an agent is working on behalf of the business owner, provide the name and address of the agent. |
| 2. Cosignee | Full name and address of business owner as cosignee to the agent importing the product. If there is no agent, indicate that the business owner is the same as the cosignee. |
| 3. Product Name | Specify the type of HCFC/HFC. Provide a NOI for each type of HCFC. |
| 4. Purpose of HCFC/HFC | List the uses of the HCFC/HFC (How will the HCFC/HFC be used?) |
| 5. Shipping Country | Country where the product is located at the time of purchase. |
| 6. Quantity of Product | Quantity of the HCFC/HFC you intend to import. If the HCFC/HFC will be purchased in different sizes, list the quantity for each size. |
| 7. Total Volume | List the total volume of the HCFC/HFC in kilograms |
| 8. Copy of Invoice | Attach the invoice of the purchase NOI form and submit it to AS-EPA for review and pre-approval. |

| 1. Copy of Manifest | Provide the manifest for AS-EPA's review. You must not ship the purchased product without AS-EPA's approval. |

**Notice of Intent to Import Hydrochlorofluorocarbons
(HCFCs)/Hydrofluorocarbons(HFCs)**



THE PURPOSE OF THE NOTICE OF INTENT (NOI) TO IMPORT HCFCs/HFCs IS TO EVALUATE ITS COMPLIANCE WITH FEDERAL AND LOCAL CLEAN AIR REGULATIONS. AS-EPA REGULATES THE PRODUCTION AND IMPORT OF HCFCs/HFCs UNDER THE AUTHORITY OF THE TITLE VI OF THE CLEAN AIR ACT. AS-EPA REQUIRES ALL BUSINESS OWNERS WITH THE INTENTION TO IMPORT ANY HCFCs/HFCs TO SUBMIT A COMPLETE NOI FORM FOR ITS REGULATORY REVIEW AND APPROVAL BEFORE SHIPMENT OF HCFCs/HFCs.
